Expert help just a few feet away made possible the rapid restarting of Billy's heart with electroshock. Brain death occurs within about five minutes after the circulation of freshly oxygenated blood stops.

It should be noted that equipment to stimulate the heart back into action is being obtained by police departments, airlines and all kinds of workplaces. You might want to encourage organizations in your area to become equipped to save lives. The electrical control system of the heart was described by Dr. Anton J, Carlson of the University of Chicago long ago, but the cause and prevention of sudden stoppage are not yet clear.

"Over the years I have learned a lot about coaching staffs, and one piece of advice I would pass on to a young coach - or a corporate executive or even a bank president - is this: Don't make them in your image. Letter to the Editor...

Sadly, I read in the summer 2001 issue of the Log that the supposed reason for the diminishing membership of the United States Jaycees was "complacency" and I do not agree with the author. Here is my observation;

When the barriers were let down and the Jaycees ceased existing as an organization made up of MEN, as originally created by our founding Fathers, the numbers started to dwindle. And will continue to do so as long as the organization that we all love so dearly is no longer a Men's organization. It is truly a shame that the women who wanted to join not only the Jaycees, but every other organization that was strictly for men, that they did not continue to build thier own organizations such as Jaycee Women, Soroptomists et cetera. The camaraderie that the men had, and that the women should have, was the driving force for the growth of our organization. Not only have the chapters lost this feeling of comradeship but also as the other organizations that have also seen a drastic drop in membership. One of the things that we must all be aware of is the destruction of our national pride and desire to build communities that embrace the concepts of our Jaycee Creed. Maybe, I am out of touch with the present day reality, but when I was State President of the California Jaycees we had 16,000+ members and 375+ Chapters. The last that I heard was that the California Jaycees now have about 3,000+ members and 75+ Chapters and the numbers are similar throughout the nation. Would we not have been a greater organization if the women and men each had their own organizations with their own goals, projects and camaraderie? If you think this idea is so flagrantly wrong ask the Rotary, Kiwanis and other organizations that are slowly going by the wayside. Wake up America, flag waving after a terrorist attack is not what made America strong-- it was organizations that loved our Country and helped make it grow. Let's get back to basics--the new program is not and will not work!

A Response...

Steve sent me a copy of his discourse on the whys and wherefore of the sad nosedive of Jaycees since our and the Jaycees' glory days. I didn't read the article that Steve refers to in the "Log", which I'm also unfamiliar with. However, if it gives the cause for the Jaycee downfall as "complacency", I agree with my friend Steve's abhorrence with that flawed analysis wholeheartedly.

There are a couple key points that require addressing here. The first being that today, as before, girls enjoy a "Girls Night Out", and boys enjoy a "Boys Night Out". The girls that I knew in Silver Spring, Maryland, and my wife was a part of it, were involved in a very active Jr. Women's Club. I like to say that I was a moving force behind having our Silver Spring Jaycees co-host a Las Vegas Nite with the girls. We had 200 plus members and they had 100 plus. I had always encouraged our wives to be active in local clubs such as the Jr. Women's club rather than have a Jaycee wives club. Our Las Vegas Nite was very successful.

On boys night out we worked on projects, attended meetings, and afterwards opened our valves at a Jaycee owned bar where Jaycee talk and politics continued. One needs to work and play together to build that camaraderie that Steve spoke of. This is easy for an all girls or all guys group to do but it isn't the same, nor is it viably accomplished in a mixed crowd. A simple example was when I was a Contracting Officer for the Navy in San Diego. Once a month a group of us would go to Tijuana, Mexico where some of the members would place some bets on horse races at the racing facility there. Then we would proceed doing what we really went there to accomplish. We would go to a different restaurant each time to enjoy each other's company telling jokes, savoring cocktails and wine, and eating something different each time.

Our group was diversified. One was a lawyer that always carried a number of new wind-up toys that he would entertain us with. Another was Manager of a large lighting company. We also had a Manager of a large Motel/Hotel near Seaport Village. The member of the group that introduced me into this hodgepodge of personalities and professions was a retired Naval Combat Pilot and past instructor at Miramar Naval Station's "Top Gun" School. He also was leader of a Jazz Banjo group. And we had a Salesman, Engineer and Doctor who rounded out the group.

We met at a designated spot each month and thoroughly enjoyed each other's company until one day the wife of the Motel/Hotel Manager came along with her husband and flippantly said, "Just treat me as one of the boys". I can see me joining one of my wife's nights out saying, "Just treat me as one of the girls". Needless to say she destroyed what we had going - male comaraderie. That ended our trips as a group to Tijuana.

The second point I wish to address is that it was Reaganomics that also was the downfall of Jaycees and other organizations. The trickle down theory only caused wives to have to become employed to satisfy the basic needs of family including house ownership - a very important foundation of family pride. Reagan and his ilk and their insensitive policies began the decay of the family structure. As a consequence, I'm sure these women that found it necessary to work also saw the need for establishing business networks which the male organizations certainly supplied more adequately than the female organizations. Consequently, the strong leaders of female organizations deserted them for male organizations and aided and abetted in the demise of these groups.

At first, male organizations didn't take lightly to the idea of women invading their sacred territories and rebelled openly. I was a District Governor at the time a young female attorney challenged one of my local chapters to gain membership. Now, that women have entered their holy ground, I'm sure that the male members are rebelling silently. For those men and women who don't achieve college accreditation, Jaycee and Jr. Women's Clubs were great learning academies. I for one feel that I gained my Masters Degree in Jaycees.

My wife has a Masters Degree in Counseling and I support her fully in all that she attempts to accomplish for the betterment of the little people in her Elementary School. But she also has to complement her salary by being a Tour Guide on holidays, weekends, and during the summer. My retirement moneys don't cut it, thanks again to Reagan. The bottom line is that the problem is a little more complex than "complacency" and "male vs female" membership. And frankly, I don't fathom how the problem will be solved until the present "Boys And Girls Nights Out" turn into positive, separate, fun nights by each group engaged in activities that benefit themselves, their families, and their communities.
