INTRO BY THE KEEPER OF THE LOG

He has the following message for all Mates of the CREW of the SS Fellowship: "Don't just sit there and watch the Jaycees disappear into oblivion. It is time for them to focus their purpose for America needs them to make our communities better places to live and train future leaders. So get up off you duffs and engage them to focus their passions as we did so the Jaycees can be a force to be reckoned with again."

We just completed a very successful 73rd Annual CREW Reunion in Crystal River, FL March 20-22, 2009. A special Thanks goes to my Chairman, Mate Jeff Dickson who did a good job. And a special thanks goes for Donations made by our Mates Moton Crockett, and Kim Newlin. A good time was had by all reports.

No sooner than the 73rd CREW Reunion was finished, the SS Fellowship set sail from Crystal River, FL for New Orleans, LA where the 74th Annual CREW Reunion will be held at the Intercontinental Hotel and Convention Center June 4-6, 2010 in conjunction with the US Jaycees Annual Year-End 2010 Convention. We will be at a 4 star diamond hotel in the French Quarter, Intercontinental Hotel & Resorts. With a room rate of only \$109/night plus tax, it's a great opportunity to see the French Quarter. In 2010, the US Jaycees have elected to have one meeting per year and it is assumed that all annual events will take place at this meeting.

Since I also keep the Roster, I have noticed a decline in the number of members of the Crew. Losses due to deaths combined with fewer nominations are factors contributing to this decline. Many current logs are returned and I fear many may be deceased that we are unaware of. Even with those US Jaycee officers who become automatic members (Mates) at the end of their tour of duty Dec 31, 2009, we will have a net loss of Mates. While keeping the roster, I have also noticed that since 1970 we have had fewer nominations of past State Presidents where as prior to 1970, over 80% of past State Presidents were nominated as Mates of the CREW. I would ask that you consider nominating your past State Presidents for membership who are not current members. Procedures to nominate to the CREW of the SS Fellowship are contained elsewhere in this issue of the LOG
