BRILE REPORT OF THE CREW REUNION April 27-29, 1979

It was a great Crew Meeting, probably the largest ever with a total of 148 registrants, and while there were never that many at any one place at one time, we did see a lot of people we haven't seen for a long time and some who were attending their first Crew Meeting.

The events were kicked off Friday night when Nicki and Chuck Shearer hosted a cocktail reception and buffet at their home in Arlington, Virginia. It was probably the closest thing to a typical national convention hospitality room which many of us haven't seen in a long time. One-hundred-forty people showed up (they thought there might be 100) and everyone had a great time renewing old friendships, singing, eating and socializing. There were even strolling musicians.

Saturday morning began with coffee and then Bill Krick introduced Dr. Arnold Moore of the American Petroleum Institute who brought us up-to-date on the fuel shortage and its causes (it was before some of us had to sit in line to get gasoline).

Dr. William Stearman of the Georgetown University Institute of Foreign Service next reviewed the United States' posture in the SALT treaties. Bill had participated in the SALT negotiations and had some insights that gave us a broader perspective of what we can expect regarding the treaties.

Because of the size of the Crew, we had to divide the crowd during the luncheon and no formal agenda item was planned. However, Eric Schmidt, a Crew member and Vice Chancellor of External Health Affairs at the University of Colorado Medical Center introduced Dr. Jack Burks who reported on the progress achieved on fighting Multiple Sclerosis (the disease Bill Brownfield died of) and the establishment of the Rocky Mountain Multiple Sclerosis Center. The possibility of this becoming a Jaycee project was presented to the Crew. The matter will be considered by the U.S. Jaycee Board of Directors and the hope is that the center may be eventually maintained in honor of Bill Brownfield.

After lunch, the Crew had the opportunity to hear from a former head of the Joint Chiefs of Staff, Admiral Thomas Moorer. His patriotic and stirring talk reminded us all of our responsibility for continued vigilance in maintaining our national military strength.

Although Admiral Moorer was a hard act to follow, former National President Richard Headlee showed that Jaycee organization, ability and know-how can have a profound effect on the affairs of our state and nation as he recounted how, under his leadership, the state of Michigan was able to adopt a constitutional amendment to control taxes and spending in that state.

Saturday evening everyone met at Fort Leslie McNair in Southeast Washington, a beautiful and historic sight and home of the Army War College, where we had cocktails, a lovely dinner and dancing in the ballroom, interspersed with running commentaries, particularly highlighted by Harry Stewart who was in unusually good form.

Tom Donnelly, former Executive Vice President, was in charge of the annual Crew fellowship held at St. Albans school on the grounds of the National Cathedral. He was assisted by Crew members Phil Knox and E.J. Plott. Tom also brought two charming guests, Gene and Shirley Browning, who gave a warm testimonial on the importance of love in our lives.

The second part of the Sunday morning event was not planned but the Crew moved to reserved seating in the Washington Cathedral where they participated in a special service commemorating the Jews who were killed in the Holocaust. It was a moving and dramatic service which reminded us all of the tragic events which befell the Jewish people in Germany in World War II.

After the service many of the Crew went to the Knoxs's for their famous morning elixir. It helped us all wind down from an exhilarating (maybe I should say exhausting) weekend.

Everyone is looking forward to the Crew Meeting next year in Tulsa. A committee of Tulsa Oldtimers are preparing the agenda and arrangements.
